Competitor Location Information



Park Competitor Spaces are 20' wide by 15' deep (and cannot be deeper due to the width of the street pace that is required for Boulder City emergency access vehicles).

After your registration has been received, we will contact you to confirm receipt and to see if you would like to express a preference of which general area you would like to be located in. We are unable to assign specific spaces until you arrive at the event...but we'll do our best to accommodate putting you in the area you would like. **Early registration receive priority on location preferences!**

Generators are not permitted near competition booths. Trailers and motor homes will be parked in or near the College of Southern Nevada parking lot (which is about 2 blocks away).

Single Product Sales & Prohibition of BBQ Samples:

Competitors are prohibited from selling food to the public unless they are a Best Dam Barbecue approved vendor and are in compliance with the Southern Nevada Health Department regulations, including permits and fees.

With specific and written approval from the Best Dam Barbecue and after payment of a reduced vendor fee (*50% of the non-competitor vendor fee*), competitors **may sell a single product** type, such as t-shirts, cooking equipment, sauces, rubs, etc. Competitors must provide a description of the product type and express approval of the Best Dam Barbecue must be granted before sales are authorized. Sauces, rubs and food items must be pre-packaged and in compliance with all Southern Nevada Health Department regulations. Competitors who sell food or a product without authorization will be immediately ejected from the competition and no fees will be refunded.

Cancellations & Deadlines

The competition entry fee includes a \$50 non-refundable processing fee, entry into 1 – 4 individual challenges and a parkside 15'x20' or a parking lot 20'x20' space the Best Dam Barbecue Challenge. If you wish to cancel your registration, written notice must be received by the Best Dam Barbecue no later than **May 1st, 2012** for you to receive a refund (minus the \$50.00 processing fee).

Liability & Media Usage Waiver:
